Contradictions: Envisioning European Futures

In many historical moments Europe's futures have seemed not simply open and uncertain, but also replete with contradiction. In the contemporary juncture, the responses both of ordinary Europeans and of the continent's collective actors and institutions to the challenges posed by crisis again constitute a series of contradictions—some of which reiterate large questions from Europe's past, while also impinging upon the ability of social forces to imagine possible futures. Europe is today a space within which the principle of social solidarity appears firmly rooted, yet also one in which the politics of austerity threaten to erode welfare state commitments. It is a context in which supra-national institutions and transnational social connections have progressed far, but also the scene of substantial efforts to reassert nationalism. It is a setting in which many are disenchanted with mainstream politics, yet also challenged by the possible growth of new movements. These – and other – tensions and contradictions manifest themselves in individual lives, social relations, institutions and collective projects. And we would like the 22nd International Conference of Europeanists to examine such opposing tendencies and, facing forward, consider the many potential futures emerging from the European crisis.

Thus, for its 2015 conference, the Council for European Studies (CES) invites proposals for panels, roundtables, book discussions and individual papers on the study of Europe, broadly defined. We encourage proposals in the widest range of disciplines, and, in particular, proposals that combine disciplines, nationalities, and generations. Although it is not mandatory that papers be related to the conference theme, papers that do so are especially welcome.

We strongly encourage participants to submit their proposals as part of an organized panel. Full panel proposals will be given top priority in the selection process. 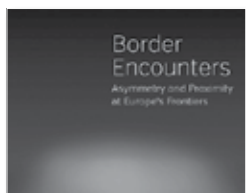

WELCOME MESSAGE

Dear CES community,

This year's conference theme is Resurrections. It is a theme which elicits a variety of perspectives and projects, but which is meant to make us think of the many ways in which the past shapes and informs the present. The program organizers, Kate McNamara and Elizabeth Dunn, have chosen a topic which can as easily steer us toward Europe at its best, to some Golden Age, as it can direct us toward less happy times, one of Europe's many "dark ages." Indeed, as I peruse the final program it seems to me that many of the images conjured by scholars of Europe are more reminiscent of *The Night of the Living Dead* than of *Back to the Future*. Sadly, many of the resurrections that are discussed in sessions or papers evoke a period of history many of us would not want to experience, such as the Interwar period and WWII. Fortunately, other resurrections have less ominous connotations. We find, for instance, presentations on ethnic revival 2.0 (paraphrasing Smith's title of the 1980s), on memory, on early welfare institutions, on almost forgotten concepts of political organization (such as Empire) that nonetheless help us make sense of the present. The program includes state of the art research on and discussion of the economic, social, cultural, and political topics and concerns making news in Europe today. And I cannot think of another conference that provides a more accurate snapshot of the state of Europe.

Just a few weeks from now, the European Union will elect a new Parliament. The election will gauge the social and political mood in a significant portion of Europe after five years of financial and economic turmoil. Media reports predict low participation rates and an increase in the proportion of elected MEPs from Eurosceptic and other non-mainstream parties. More generally, there are signs throughout Europe that disaffection with the established political parties and leaders, with the functioning of democracy, with the European Union, with economic inequalities and declining standards of living, and with ethnic and religious diversity are on the rise. This conference offers a unique opportunity to reflect on and propose explanations for these trends. I am convinced too that it will be the setting for civilized and principled debate, in and out of the meeting room, about the various politi-

cal options open to Europe and its component states.



There is also an official conference app available for download on all Android, Apple, and Blackberry devices. This app includes information about sessions, locations, exhibitors, and special events. Information on how

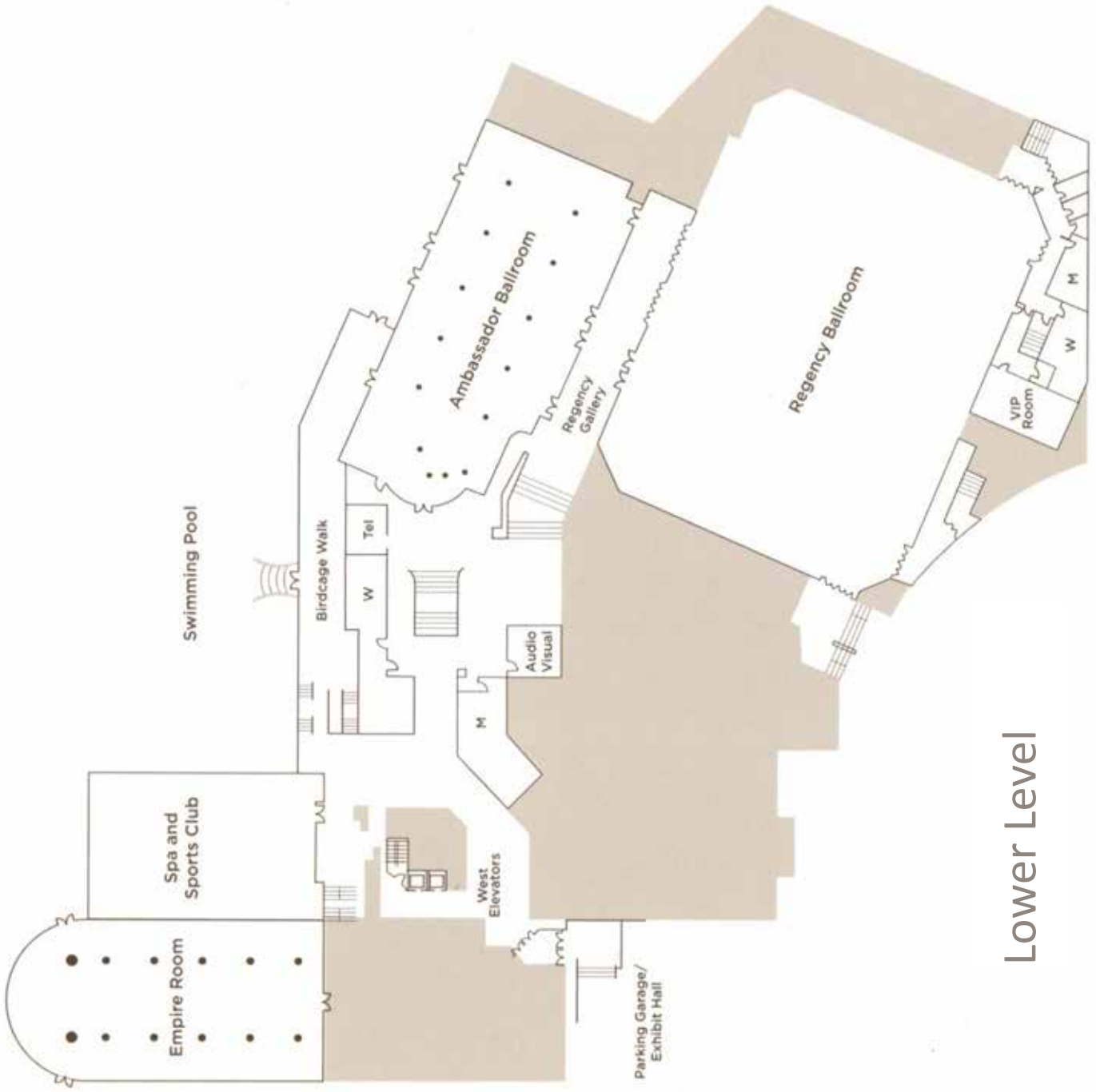

The Afterlife of Bad Ideas

Morality in Contemporary European Society and Politics

The financial and economic crisis of the last five years has distracted the public from worrying social and political trends that threaten to “resurrect” aspects of Europe’s darkest hour, back in the first half of the twentieth century. First, civil and political corruption is contributing to growing distance between citizens and their representatives and to political apathy. Second, growing intolerance and stigmatization of ethnic minorities and immigrants, passively watched or even condoned by govern-

ing elites and expressed in part in the rise of populism and far-right parties, contradicts core values of European democracies. The upcoming European election may reflect both trends in the form of massive abstention and the success of candidates from Eurosceptic and xenophobic political parties.

This plenary panel brings together three prominent scholars who have long reflected on Europe’s political and moral crisis from different thematic angles and through different methodologies.
